

# **Business Credit Analyst - Position Description**

#### **POSITION SUMMARY**

Utilizing knowledge of business lending, evaluate members' credit data and financial statements in order to determine the degree of risk involved in lending money to them. Situations can move quickly from low stress to high stress and can require flexible hours.

### **ESSENTIAL FUNCTIONS**

- Evaluate members' credit data and financial statements in order to determine degree of risk to the credit union when lending money and provide recommendations to the approval committee
- Provide timely, accurate and complete reports to determine the degree of risk in lending money to business clients
- Analyze client records and using the data to recommend payment plans
- Evaluating the financial status of members' by producing financial ratios through computer programs and spreadsheets
- Completing loan applications and including the credit analysis and loan request summaries, then submitting these to the loan committee for approval as a non-voting member
- Collaborate with IT and marketing departments to ensure relevant information is provided to reduce risk of member disputes and make payments on time
- Confer with members to verify financial/credit transactions and to resolve complaints
- Make recommendations to TOPCUs policies and procedures that increase efficiency whilst remaining compliant to relevant federal, state and local laws and regulations
- Conduct appraisal reviews
- Verify credit references and information and determine credit limits
- Exist as back up to underwriting and business & mortgage loan processor as needed
- Order credit reports and all other certifications as necessary
- Provide consistent, excellent customer service to both internal and external members
- Assist team members with questions and concerns and provide necessary/requested information
- Collaborate with colleagues to ensure loan files are kept organized & current
- Assist in retrieving documents for reports, audits and exam requests
- Provide notary service
- Meet or exceed all deadlines per regulatory and internal requirements
- Perform other duties as assigned
- Mandatory compliance of all BSA/AML regulations, forms and procedures:
  - Maintain awareness of and report suspicious activity
  - o Complete annual BSA training
  - o Notify immediate supervisor of any substantive discrepancies
