You will also receive a 1099 Interest form if you earned \$10 or more in dividends or a 1098 Mortgage Interest form if you paid more than \$600 in loan interest on your home loan.

Using a store credit card for holiday shopping rewards was smart. But now are the high interest rates knocking the wind out of your budget?


